480 V, 1-PH, 50/60 Hz and 200-600 V, 3-PH, 50/60 Hz options, with a power rating of 9 KW, which does not adhere to EU standards. These specifications need to be adjusted to align with the EU standard of 230/400 V, 3-PH, 50/60 Hz, resulting in a maximum power of 8.5 KW.

Question n.26

With reference to LOT 5 - Item 5.5 – plasma machine, The required specifications meet the US standard requirements; however, the USA is not eligible as the origin of goods. Therefore, please verify the following to ensure compatibility with EU products and standards as for point 5.5.3 specifies that the inlet gas pressure falls within the range of 7.6–8.3 bar, with a minimum inlet gas pressure of 5.2 bar, which is designed for US products but is not suitable for EU products. It's worth noting that EU standards typically require plasma machines to operate within a compressed air pressure range of 4 to 5 bar. Kindly verify whether the compressed air pressure range of 4 to 5 bars is acceptable.
